Short financial overview

Wirtek showed resilience in 2023 and a great ability to adjust to shifting markets and an inflation-driven cost pressure. **Revenue grew by 7%** to DKK 70.4 million with operating profits (EBITDA) of DKK 6.3 million compared to 7.5 million in 2022. Our focus on renewable energy has paid off with **a growth of 70% during 2023 in our Energy business unit**.
